Session 4, May 19 Immunopsychiatry: Infections, Inflammation and the link with Mental Health

Dr. Michael E. Benros, MD, PhD, is Professor of Immuno-Psychiatry at the University of Copenhagen and head of research on Biological and Precision Psychiatry at the Mental Health Centre Copenhagen, Copenhagen University Hospital. He is recognized internationally for being at the forefront of the emerging field of ImmunoPsychiatry and has helped advancing the field through several landmark papers highlighting the association between immune-related factors and mental illness utilizing Danish nationwide registers and biobanks, cohort studies and metaanalysis.



Session 5, May 26 The Pandemic Ethics
